- Biografiy (in Italiano,e English)
- Link social (Facebook, Instagram, Spotify, Youtube).

All these details are essential for radio sponsorship and tracking audio.

Please note that all radio stations with which GD RECORDS MUSIC collaborates are located in territories covered by copyright agreements.

Therefore, the radio stations will pay all the necessary rights and, consequently, all the radio broadcasts will generate royalties payments that the author will receive directly from the entity that manages them (Ascap, Bmi, Siae, etc.) and not from the GD MUSIC RECORDS
